- Ms. McLemore reported on behalf of the Library Board's Finance Committee:
  - The FY2013 library audit report was emailed prior to today's meeting. The library received a clean audit. The only exception was in regards to transferring the sum of \$150,000 from the operating fund to the City-County fund. This resolution was voted on and approved at the January 9<sup>th</sup> Board meeting. A copy of the approved resolution will be sent to Mr. Branum.


- Mr. Mallory made a motion to approve the report from the Finance Committee. Ms. Atkins seconded the motion. Motion approved unanimously.

***Status of Questplex Project (provided by Mayor Strange):***

- Mayor Strange provided a status on the Questplex Project.
  - The project cannot move forward as it was originally planned.
  - There will be a press conference at 1:30 pm on Friday, March 21, 2014.
  - The New Library Planning Committee will be reactivated to take into consideration the original plans approved in April 2012 and the present situation in order to cooperate with the City and move forward in a different direction.
  - Ms. Sanders made a motion that the Library Board approves having a library based upon technology at One Court Square. Ms. McLemore seconded the motion. Motion approved unanimously by the Library Board.
